NOTIFICATION

In view of recent developments i.e., huge growth in residential and commercial establishments, volume of traffic is very high on Kokapet Rotary and on the ORR service road between Kokapet Rotary and the Vehicular Under Pass near Vertex Panache. This is leading to severe traffic congestion daily. Based on frequent traffic congestion and road safety issues, the following permanent traffic diversions will be implemented for the safety of the commuters, pedestrians and for effective traffic management in the area.

Hence, in exercise of the powers conferred upon me under section 7 Clause (1) of Cyberabad City Police Act r/w Section 21 Clause (1) (b) of Hyderabad City Police Act 1348-F, I, V.C. Sajjanar, IPS, Commissioner of Police, Cyberabad do here by notify for the information of general public, that the following restrictions/rules are imposed in the interest of road safety:

ONE WAY TRAFFIC ROUTE:

Vehicular Traffic movement on the road from Kokapet ORR Service Road Rotary (Financial District side) – Vehicular Under Pass (VUP) near Vertex Panache – Kokapet Rotary (GAR side) shall be uni-directional in the same direction. (Map of the route enclosed).

DESCRIPTION OF ROUTES:

1. The traffic coming from ISB, Financial District side going to GAR building shall take left turn on to the ORR service road at Kokapet Rotary -1 move upto VUP – Right turn – Vertex Panache – GAR building.
2. No straight movement of traffic from ISB side towards GAR building Via Kokapet underpass rotary will be allowed.
3. Traffic coming from Kollur side on ORR service Road going towards Narsingi will not be allowed straight. It has to take left at Kokapet rotary and move on the ORR service road on Financial District side upto the VUP near the Vertex Panache.

All the citizens/ IT employees are requested to co-operate with Traffic Police in view of public safety and free flow of traffic.

The above restrictions will come into force from 14.10.2019 and those found violating the above restrictions will be liable for action under relevant sections law.



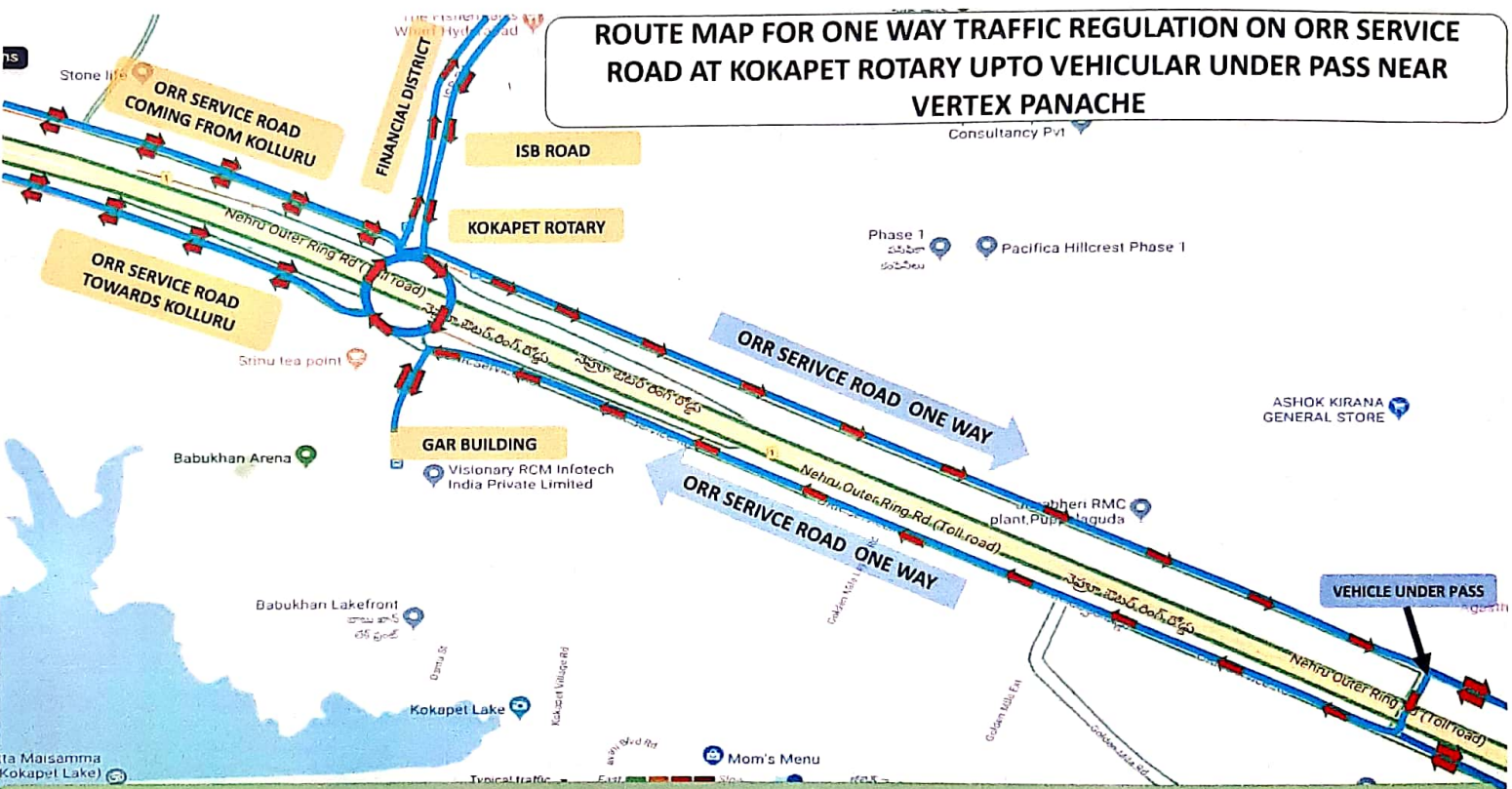
