NOTIFICATION

Sub:- Streamlining of Traffic movement on the ORR Service Road in Nanakramguda area – One Way traffic movement regulation – Notified – Reg.

In recent years, the areas along the ORR service road in Nanakramguda area have witnessing brisk growth owing to developments in the surrounding areas. The population and the vehicular volume on the service roads have seen a tremendous rise recently. The ORR Service roads have become accident black spots in these areas due to ever increasing vehicular volume; insufficient carriage capacity; etc. Also, the road is witnessing regular traffic congestion between Nanakramguda and the Vehicular Under Pass (VUP) near My Home Avatar.

In this background, it is proposed to streamline the traffic movement on the ORR Service Road in Nanakramguda area by putting in place certain traffic diversions / restrictions in view of road safety and better management of traffic in the area.

Hence, in exercise of the powers conferred upon me under section 7 Clause (1) of Cyberabad City Police Act r/w Section 21 Clause (1) (b) of Hyderabad City Police Act 1348-F, I, V.C. Sajjanar, IPS, Commissioner of Police, Cyberabad do here by notify for the information of general public, that the following restrictions/rules are imposed in the interest of the road safety:

ONE WAY RESTRICTION:

The traffic movement on the ORR Service Road from Nanakramguda Rotary-1 (towards Khajaguda side) upto Vehicular Under Pass (VUP) near My Home Avatar and via VUP towards Nanakramguda Rotary-2 (towards Nanakramguda side) will only be Uni-directional in same direction as mentioned above. (Map of the route enclosed)

DESCRIPTION OF ROUTES:

1. Traffic coming from Narsingi towards Khajaguda on ORR service road shall move via Narsingi – VUP (My Home Avatar) – Lansum Etania Complex – Pride Honda – Rotary-2 – Rotary-1 – Khajaguda.
2. The traffic movement via VUP near My Home Avatar will also be Uni-directional (from east to west) i.e., from My Home Avatar side towards Kokapet side.




